Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  • WC has no affiliates.		
Nonaffiliates or Third-Parties	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  • WC does not share information with nonaffiliates or third-parties so they can market to you.		
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • WC does not jointly market.
